Notice of Annual General Meeting

The AGM will be held at 11.00 am on Tuesday 15 May 2018 at The Academy of Medical Sciences, 41 Portland Place, London, W1B 1QH and the notice of the AGM (the "Notice") can be found on pages 4 and 5 of this document. A map of the venue is shown on the reverse of the attendance card.

I will be exercising my right under the Company's Articles that all resolutions at the AGM will be voted by way of a poll rather than a show of hands. The Board and I consider that a poll is in accordance with good corporate governance since it allows the votes of all shareholders who have submitted a proxy form to be counted. Shareholders attending the AGM will have the opportunity to ask questions of your Board and vote on the resolutions proposed. The outcome of the vote at the AGM will be announced by way of a Stock Exchange announcement after the close of the AGM and will be published on our website.

Whether you propose to attend the AGM or not, please complete the enclosed proxy form and return it to our registrars, Link Asset Services. They must receive it no later than 11.00 am on Sunday 13 May 2018. The return of the proxy form will not prevent you from attending the AGM and voting in person should you so wish.

I set out below a short explanation of each resolution at the AGM. Resolutions 1 to 13 are ordinary business as the Company considers these to be matters that would usually be dealt with at an AGM. Resolutions 14 to 17 are special business. Resolutions 1 to 14 are ordinary resolutions and require a simple majority of votes cast to be in favour of the resolution to be approved. Resolutions 15 to 17 are special resolutions and require at least 75 per cent of votes cast to be in favour of the resolution to be approved.

Resolution 1

Report and Accounts

Resolution 3

Final Dividend

The Directors have recommended a final dividend for the year ended 31 December 2017 of 20.1 pence per ordinary share.

Resolutions 4 to 11

Reappointment of Directors

The Company's Articles require that each Director must offer himself or herself for reappointment every year. Accordingly a separate resolution for each Director to seek reappointment is included in the Notice. We ask shareholders to approve the reappointment of each of the following members of the Board: John McDonough CBE, Stephen Bird, Martin Green, Kath Kearney-Croft, Christopher Humphrey, Lorraine Rienecker, Richard Tyson and Caroline Thomson. Mark Rollins will not be standing for reappointment as he will cease to be a director on 2 April 2018.

Biographical details for each Director as at 31 December 2017 are set out on pages 52 and 53 of the 2017 Annual Report. Biographical details for Richard Tyson who will be appointed a director on 2 April 2018 are set out below. As a Non-Executive Director, Richard Tyson will receive the base fee for a Non-Executive Director of £45,255 per annum.

Richard Tyson, age 47, appointed as a Non-Executive Director with effect from 2 April 2018. Richard is Chief Executive Officer of TT Electronics plc, holding that position since 2014. He was formerly President of the Aerospace & Security Division of Cobham plc from 2008 to 2014 and a member of their Executive Committee. He was previously responsible for TRW Aeronautical Systems (formerly part of Lucas Industries) European aftermarket business before joining Cobham plc in 2003 to run its Flight Refuelling Division. Richard is a fellow of the Royal Aeronautical Society.

In accordance with the UK Corporate Governance Code, an external Board performance evaluation was carried out in 2017, as a result of which the Board believes that each of the Directors seeking reappointment is performing to the highest standards, continues to be an effective member of the Board and demonstrates commitment to the role. The Board further confirms that each Director continues to provide independent character and judgment to the running of the business particularly reviewing strategy, risk management, succession planning and ongoing financial and business performance.

Resolutions 12 and 13

Appointment of Deloitte LLP as auditor and authorisation for the Directors to set the auditor's remuneration

The Company is required to appoint an auditor at each general meeting at which its accounts are presented. During 2017, the Board oversaw a formal and comprehensive tender process for the external auditor appointment. KPMG, due to the length of their tenure, having been appointed in 1995, did not participate in the tender. We announced on 22 February 2018 that following the audit tender exercise KPMG would not seek re-appointment at the Company's 2018 AGM and that Deloitte LLP would be recommended to shareholders for approval at the 2018 AGM to succeed KPMG LLP as the Company's auditor for the financial year commencing 1 January 2018. Full details of the process is set out in the Audit Committee report on pages 65 to 69 of the 2017 Annual Report and Accounts. The outgoing auditor, KPMG, is to provide the Company with a statement of the reasons, as required by the Companies Act 2006 and we will circulate that to shareholders once received.

The Company is required to appoint an external auditor at each general meeting at which accounts are laid, to hold office until the conclusion of the next such meeting.

Resolution 12 therefore proposes the appointment of Deloitte LLP as the Company's auditor to hold office from the conclusion of this meeting until the conclusion of the next general meeting at which accounts are laid before the Company.

Resolution 13 seeks to authorise the Board to set the remuneration payable to the Company's auditor. Details of the remuneration paid during the year ended 31 December 2017 to the outgoing auditor, KPMG LLP, can be found on page 67 of the 2017 Annual Report.

Resolution 14

Allotment of share capital

This resolution would give the Directors authority to allot ordinary shares or grant rights to subscribe for or convert any securities into ordinary shares up to an aggregate nominal amount equal to £899,807 (representing 4,499,039 ordinary shares of 20 pence each). This amount represents approximately 10% of the Company's issued ordinary share capital (excluding treasury shares) as at Friday 23 February 2018, the latest practicable date prior to publication of this Notice. A similar resolution was approved at the 2017 AGM and will expire at the 2018 AGM. The Directors therefore wish to seek a renewal of this authority.

The Directors will exercise this authority only when to do so would be in the best interests of the Company and of its shareholders generally, and could be expected to result in an increase in the Company's earnings per share.

Ordinary shares purchased by the Company pursuant to this authority may be held in treasury or may be cancelled. Notice of general meetings

This special resolution is required to reflect changes made to the Companies Act 2006 by the Companies (Shareholders' Rights) Regulations 2009 which increase the notice period required for general meetings of the Company to 21 days unless shareholders approve a shorter notice period, which cannot however be less than 14 clear days. (AGMs will continue to be held on at least 21 clear days' notice.)

This special resolution seeks shareholders' approval to hold general meetings on a shorter notice period of no less than 14 clear days.

The shorter notice period of 14 days would not be used as a matter of routine for such meetings, but only where the flexibility is merited by the business of the meeting and is thought to be to the advantage of shareholders as a whole. The provisions of the Companies Act 2006 mean that, in order to be able to call a general meeting on less than 21 clear days' notice, the Company must make a means of electronic voting available to all shareholders for that meeting.

The approval will be effective until the Company's AGM in 2019, when it is intended that a similar resolution will be proposed.

A similar authority was sought and given by shareholders at the 2017 AGM.
